# REGULATIONS FOR PARTICIPANTS OF SELF-GUIDED EVENTS ORGANIZED BY "IMPREZART MARK WESTIN"

## § 1 General Provisions

- 1. These Regulations (the "Regulations") specify the general conditions for the participation in self-guided events ("Game"), organized by "Imprezart Mark Westin", registered at ul. J. Mianowskiego 24/3, 02-044 Warsaw, NIP: 6771506597, entered to the Central Registry and Information on Economic Activity ("Organizer").
- 2. All Participants in the Games, who use the services of the Organizer, are obliged to refer to these Regulations.

### § 2 Game Participants

- 1. Participation in the Game is entirely voluntary, and Participants participate in this Game at their own risk.
- 2. Only adult natural persons with full legal capacity ("Participants"), and who are not under the influence of alcohol or other drugs, may participate in the Game.
- 3. Each Participant is obliged to comply with the Regulations, as well as the provisions of applicable law, health and safety regulations, fire regulations, traffic regulations and behavior in a way that does not threaten the life and health of other Participants, as well as third parties.
- 4. Participants are obliged to strictly follow the guidelines of the national authorities regarding the pandemic. In particular, Participants that are quarantined or suffering from COVID-19 or other infectious diseases may not participate in the Game, and Participants must keep appropriate distance and maintain strict sanitary rules.

#### §3 Safety

- 1. The Organizer declares that the Game area will take place in publicly accessible spaces and will be suitable for pedestrian use.
- 2. The route, as well as the tasks entrusted to Participants to perform, are prepared by the Organizer in such a way that they do not pose a threat to the life or health of the Participants, nor to safety and public order. Each Participant will receive the necessary guidance to reach the required locations.
- 3. If a Participant believes that a particular location of the Game might be dangerous, or finds themself in a place dangerous or not allowed for pedestrian traffic (due to incorrect reading of the directions prepared by the Organizer, road works, construction, etc.), they are obliged to immediately inform the Organizer of this fact, and in any case must not perform any activity that may be dangerous or illegal.
- 4. Liability for injuries caused and the possible consequences of being in weather conditions in which the Game will be carried out lies entirely with the Participant.

### §4 Photos / Personal data protection

- 1. A photo report containing the image of the Participants ("Photos") may be made during the Game. The condition for use of photos by the Organizer is the Participant's physical or electronic consent to the processing of the image captured in the form of a photo or video for marketing and promotion purposes conducted by the Administrator of Personal Data and entities processing personal data on his behalf.
- 2. The Administrator of Personal Data referred to in this paragraph is Mark Westin.
- 3. The Organizer declares that he will process personal data only for marketing and promotional purposes.
- 4. The Organizer, in order to maintain proper protection of personal data made available in connection with the organization of the Game, or entrusted during the Game, in particular regarding the compliance of the processing of such data with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC ("GDPR"), agrees to process the personal information in accordance with the applicable laws and provisions.
- 5. Participants have the right to access their personal data, rectify it, update it, raise an objection, or withdraw consent to the storage or processing of personal data. The Organizer ensures that he does not use personal data for purposes other than marketing and promotional purposes, in particular he does not sell personal data or make them available to other entities.
- 6. In order to process personal data, the Organizer will use appropriate technical and organizational measures to ensure proper security and protection of personal data in such a way as to ensure an adequate level of their security, corresponding to the risk associated with the processing of personal data, and to prevent the unlawful use of personal data or their availability for unauthorized third parties.
- 7. If the achievement of marketing and promotional purposes will require entrusting the processing of personal data, the administrator of personal data may entrust the entity processing this personal data for processing pursuant to art. 28 of the Regulation by way of a separate agreement, on the terms and for the purpose specified in the agreements concluded in connection with the conduct of a marketing or promotional campaign.
- 8. Persons processing personal data in connection with the organization of the Game will be acquainted with the provisions on the protection of personal data, as well as criminal and civil liability for non-compliance, and will undertake to comply with these provisions, and to maintain data privacy and security.
